Established in 1967, Wasatch Behavioral Health (WBH) is a Public Comprehensive Behavioral Health Center providing a variety of services designed to meet the needs of children, youth, adults, and their families throughout Utah and Wasatch Counties.

WBH is staffed by licensed professionals who specialize in mental health and substance use recovery. These professionals include Psychiatrists, APRNs, Nurses, Clinical Psychologists, Marriage and Family Therapists, Clinical Social Workers, Clinical Mental Health Counselors, Substance Use Disorder Counselors, Adult and Youth Case Managers, Peer Support Specialists, Residential Service Staff, Family Resource Facilitators, Parent Mentors, Care Team Assistants, and a comprehensive administrative business staff.

State law assigns the responsibility of administering local behavioral health services to county government. WBH is a Special Service District of Utah County governed by the oversight of the Utah County Commissioners, who serve as the agency's Authority Board.

EXECUTIVE MESSAGE

We present the annual report of Wasatch Behavioral Health (WBH) to the Board of County Commissioners, local and state government officials, allied agencies, and the citizens of Utah and Wasatch Counties.

We deeply appreciate the many collaborative community partnerships with allied agencies, housing authorities, law enforcement, and other treatment providers. Utah County and WBH are well known for their collaborative community and excellent integration of services.

Commissioners Amelia Powers Gardner, Brandon Gordon, and Thomas Sakievich show exceptional support and a strong commitment to our mission and goals. We appreciate the contributions and support from Commissioner Thomas Sakievich, and we look forward to Commissioner Skyler Beltran joining our Authority Board. Their service on our Authority Board is greatly appreciated.

Several significant expansion projects have been completed or are near completion. Earlier in the year, we opened the Eagle Mountain Family Clinic to enhance access in this fast-growing area of our community. The clinic has been well received and we are already adding staff to increase service availability. After the recent completion of the Payson facility expansion, Mountainlands Community Health Center opened its doors to provide access to much-needed healthcare services in the southern part of Utah County. Services offered include physical healthcare, dental, and a full-service pharmacy. This is the third location where we are co-located with Mountainlands. Our Substance Use Disorder services, currently housed in the County Health and Justice Building, will relocate to a larger facility in Orem. The remodel of this facility will be completed by the end of 2024.

Our Forgivable Loan Program, initiated several years ago to address the critical workforce shortage, has been highly successful. As of this writing, we have 24 individuals who completed a master's degree program to join our ranks of highly qualified behavioral health therapists.

Clinically, Wasatch Behavioral Health markedly increased its implementation and utilization of Lyssn software throughout the agency. This AI tool accurately and confidentially provides clinicians with feedback regarding how well their interventions adhere to the standards for best practices, like Motivational Interviewing and Cognitive Behavioral Therapy. This feedback provides clinicians with the information they need to improve therapeutic skills to assist their clients in obtaining better clinical outcomes.


Securing funding through state appropriations, we have brought our Assertive Community Treatment (ACT) team to fidelity and increase service capacity. We were also able to expand the Mobile Crisis Outreach Team (MCOT) availability in Wasatch and Summit counties to 5 days a week/ 24 hours a day.

Goals for this next year relate to further enhancing client access through the development of a client portal. Eventually, we hope to allow clients to schedule appointments and access their clinical records online.

Other goals include deploying a second Assertive Community Treatment (ACT) team in the Northern part of Utah County, pursuing sustainable funding for the health integration project with Mountainlands Community Health Center, and expanding MCOT services in Wasatch County to 7 days a week/ 24 hours a day.

We look forward to continue to enhance access, capacity, and clinical outcomes for our clients and the community.

FISCAL YEAR 2024 HIGHLIGHTS

- Opened an outpatient clinic to serve the Eagle Mountain/Saratoga Springs area.
- Increased monitoring of clinicians utilizing the Y/OQ and SURE measurement tools.
- Expanded The Bridge Team (ACT model) to full fidelity and doubled the number of clients served.
- Increased utilization of the SURE, a clinical outcome measure for clients with SUD.
- Wasatch House received a 3-year accreditation from Clubhouse International.
- Implemented SUD services in the Payson Family Clinic.
- Expanded Wasatch County MCOT to 24 hours/ 5 days a week coverage.
- Completed the Payson Family Clinic expansion to co-locate with Mountainlands Community Health Center.
- Aspire program received a 3-year CARF accreditation.
- New clinical approaches lowered critical incidents by 35% at Vantage Point and 72% at Aspire.
- 384 clients used Opiate Settlement County funds, which assists clients with opioid use disorders in treatment transition into apartments and assists with deposits for the first-month rent and start-up furniture.
- Medication Assisted Treatment (MAT) provided to approximately 85% of justice-involved individuals, which has proven to be successful in reducing criminal activity, repeated arrests, probation revocations, and repeated incarcerations.
- SUD increased the number of clients served in the Drug Court program from 60 to 70 individuals. 84% of these clients have Medicaid, including Youth Drug Court clients.
- 3 Peer Support Specialists from the Substance Use Division were recognized for their outstanding work.
- Center for Opiate Recovery (COR) received a 3-year CARF accreditation.
- Increased the percentage of clients reporting that they have improved or recovered in treatment (as measured through Y/OQ tools) by 3% for adult clients and 5% for youth clients compared to 2022.
- Developed and implemented the Help Ticket 2.0 system to increase the speed, efficiency, and transparency of several administrative processes with the aim of making it simpler for all staff to access administrative support and to better meet the needs of a growing agency with the use of existing staff.
- WBH staff provided over 500 hours of behavioral health education to schools, law enforcement, allied agencies, and community members.

FISCAL YEAR 2025 GOALS

- Open a second Bridge Team in North Utah County, pending available funding.
- Pursue sustainable funding to continue the Health Integration Program into FY26 and beyond.
- Complete renovation and construction to move all Substance Use Disorder programs currently located in the County Health & Justice Building to the new location in Orem.
- Increase monthly SURE administration to 60% for clients with primary substance use disorder diagnosis.
- Update network to improve connectivity and implement isolation measures to increase network security.
- Assist 1000 clients in obtaining or requalifying for funding so they can receive behavioral health services.
- Develop a system of Power BI Dashboards to provide program managers with timely access to current information and to aid them in improving the effectiveness of their programs.
- Expand Wasatch County MCOT to 24 hours/ 7 days a week.
- Begin development of a client portal to include a client self-scheduling system.






FY2024 Total Revenues By Source


FY2024 Expenditures

\$66,481,346*




Clients Served By Age




Clients Served By Gender




Ethnicities

EXPANSION PROJECTS



The Eagle Mountain Family Clinic opened in February 2024.
The clinic offers individual therapy and psychiatric services for children, adults, and families.
We are proud to offer services closer to home for our clients who live west of Utah Lake.



WBH purchased and is remodeling a building located at 255 South Orem Blvd., in Orem.
We anticipate our Substance Use Disorder Division programs moving out of the Utah County Health and Justice Building and into their new space by the end of 2024



The Payson Family Clinic expanded in June 2024 to include integrated healthcare with Mountainlands Community Health Center. The clinic provides dental, medical care, and full pharmacy services. The expansion also included the addition of specialized sensory therapy rooms for WBH.

PROGRAM SUCCESS

During FY2024, Wasatch Behavioral Health significantly increased the implementation and utilization of Lyssn software throughout the agency.

The Lyssn software is an AI tool that accurately and confidentially provides clinicians with feedback regarding how well their interventions are adhering to the standards for best practices like Motivational Interviewing and Cognitive Behavioral Therapy (CBT). This feedback provides clinicians with the information they need to improve therapeutic skills in ways that will assist their clients to obtain better clinical outcomes.

During the last fiscal year, over 70 WBH clinicians submitted over 2700 sessions for review, with the vast majority of those sessions exceeding fidelity standards for the evidence-based practice in question.

During the coming year, we will continue working on increasing the frequency with which this tool is used, and consequently, the quality of services we provide.

DIVISION SUMMARY

The Corporate Compliance Division is comprised of several administrative departments. Though small in size, it works with other departments and divisions across Wasatch Behavioral Health to ensure the center's compliance with laws and regulations, maintain and provide access to medical records, improve clinical service quality, and to develop innovative tools and services with the ultimate goal of efficiently providing the highest quality of services to WBH clients while meeting all regulatory requirements.

SUBSTANCE USE DISORDER DIVISION

PROGRAM SUCCESS

Paul (*name changed*), a middle-aged, divorced man, whose children were removed from his home and placed in foster care due to substance use was admitted to Intensive Residential Treatment (IRT).

Paul had recently been evicted from his apartment due to unpaid rent. He was estranged from his family, and he had no place to go. Paul initially struggled with trusting the staff at IRT and was reticent to allow nursing staff to co-manage his diabetes. He agreed to attend groups but sat in the back apart from others. He was guarded and would often isolate in his room.

With time and a lot of encouragement, Paul eventually came to trust the IRT staff. He worked with the nurses to learn how to manage his diabetes and other physical issues. He also engaged in groups, individual therapy, and met with his addiction therapist weekly. The prescriber was able to get him started on an anti-depressant while at IRT. The case managers assisted Paul in applying for Social Security benefits and applying for housing assistance.

After 3 months of intensive support, Paul was able to discharge from IRT. He continues to remain stable and follows up with his substance use team and prescriber regularly.

DIVISION SUMMARY

The Substance Use Disorder Division provides a range of outpatient and residential treatment services to include an intake and assessment office, detox and residential facility, outpatient treatment with assigned therapist and case management teams, a CLIA certified lab, certified methadone dispensing, addictionologist medical doctor providing medication-assisted treatment, peer support services, and several criminal justice programs serving Utah County residents and individuals who are homeless.

PROGRAM SUCCESS

One of our clients had been homeless for almost a year and due to criminal behavior, he was not able to find an apartment. He tried staying at a local budget motel, but his funding would only pay for about 2 weeks of a month. Even through the cold winter months this individual struggled through it all. His case manager worked very hard on this client's behalf and helped him secure an apartment within his price range, which is a miracle. He is now housed and supporting himself.

The Wasatch County Family Clinic Prevention Team has achieved significant milestones, reinforcing our commitment to youth development, substance use prevention, and suicide prevention. Throughout the year, the team provided over 250 hours of prevention education to the community and students in Wasatch County.

The team participated in the THRIVE Winter Retreat where high school club members took the lead in training their middle school counterparts, fostering a collaborative environment. This event exemplifies the positive influence that we instill in the schools and community to empower and uplift the younger generation in Wasatch County.

DIVISION SUMMARY

The Clinical and Community Services Division provides family outpatient care to individuals recovering from a primary mental health condition in Utah and Wasatch Counties. Services include psychiatry, psychotherapy, case management, and peer support that are delivered in clinics, schools, or client homes. Services are available in person or via telehealth. Our Clubhouse, Supported Housing, Bridge Team, Representative Payee Services, and PREP Team provide specialty care to clients who qualify.

PROGRAM SUCCESS

A child in DCFS custody enrolled in Stride recently completed the program. When starting services in the Spring she displayed many psychosomatic issues such as heaving and hyperventilating. Through consistent treatment supports offered in STRIDE along with collaborative efforts with DCFS and the family, she has not displayed these behaviors at all over the summer. Her DCFS case has also progressed to the point where she was able to return home to her family!

Another recent Stride graduate had this experience: When he started, he would become emotionally dysregulated quite easily and cry, yell, and run away; sometimes multiple times per day. After working in the program, he could participate in all Stride activities every day without becoming dysregulated. Stride staff and his family worked together to figure out the right supports for him.

DIVISION SUMMARY

The Crisis and Intensive Services Division provides interventions for those in crisis or with acute behavioral health needs. This includes mobile outreach services, crisis shelter care, residential treatment programs for youth, and a pre-school for children on the autism spectrum with mental health needs. In addition, we provide full and partial day treatment programs for children and youth.
